Sub: Combined Report on Remote e-voting and voting by Ballot conducted at the 26th Annual General Meeting of SPS Finquest Ltd.

- I, Upendra C. Shukla, Practicing Company Secretary, was appointed as the Scrutinizer by the Company to scrutinize the electronic voting process. I was also appointed as scrutinizer to scrutinize the voting by means of Ballot at the 26th Annual General Meeting (AGM). The said appointment was for ascertaining the requisite majority on e-voting as also on Ballot carried out for the resolutions proposed to be passed at the 26th AGM of the Shareholders of the Company, held on Wednesday, the 28th September, 2022.
